

THIS IS A SEPARATE APPLICATION FOR A SPECIAL EXHIBIT

Make a finished quilt block 18 inches square in **red, white, and blue**. Attach 7- inch ties to the four corners of the block so that all the blocks can be tied together. Feel free to use a variety of techniques (appliqué, pieced, embroidered, painted, or dyed) for your quilt block. Our Quilt Show will have a special display showcasing all of the finished blocks.



Guidelines and Procedures: (Please read carefully)

1. Block entries must be 18" x 18" and in **red, white, and blue** with 7-inch ties (attach 2 at each of the 4 corners.)
2. You may only enter **two** 18" x 18" blocks. This block will not count towards the **4 quilt entries** that you can enter in the show.
3. The paper "Label" must be sewn to the lower **right corner** on the back of the block.
4. Each entry must include a color digital photo of the entry and can be texted to Cathy.
5. Each entry must include a signature and date on the Insurance Waiver.
6. Block entries must be delivered to **William Jessup Event Center, 2121 University Avenue, Rocklin, CA on Thursday, May 7th between 3:00 PM and 4:00 PM**
7. Entries must be **picked up on Saturday, May 9th between 5:00 and 5:30 PM**. You must present your "Receipt" to claim your entry. **NO entries may be picked up before 5:00 PM. NO EXCEPTIONS!**
